The Government of India has received/applied/ intends to apply for financing from the World Bank towards the cost of NCRMP & NCRMP(AF) project and it is intended that part of the proceeds will be applied to eligible payments under the contract for supply of following type of emergency equipment for 154 nos. cyclone shelters under NCRMP and 162 nos. cyclone shelters under NCRMP (AF) in the state of Odisha.
2. The Government of Odisha intended to procure the same emergency equipment under this contract for 308 nos. cyclone/flood shelters under SDRF.
3. The Odisha State Disaster Management Authority, Bhubaneswar (Purchaser) now invites online bids from eligible bidders for supply of emergency equipment as listed below.


- 4 Bidding will be conducted through the National Competitive Bidding (NCB) procedures agreed with World Bank. The bidding is open to all eligible bidders as defined in the Bank's Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 of the Guidelines setting forth the World Bank's policy on conflict of interest.
- 5 Bidding documents are available online on <https://tendersodisha.gov.in/>, (Perspective eligible bidders can apply as per the procedure described in paragraph 7 below along with the terms agreed with the e-procurement portal). Bidders will be required to register in the website, which is free of

cost. The bidder would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.

- (a) Price of bidding document : **Rs. 4000/- (Rupees Four Thousand Only)**

6. For submission of the bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities, authorised by Government of India for issuing DSC. Aspiring bidders who have not obtained the user ID and password for participating in e-procurement in these Projects, may obtain the same from the website: <https://tendersodisha.gov.in/>. Other documents listed in paragraph 7 below shall be submitted to the TIA before the opening of the bid i.e. before **25/04/2018 at 11.00 AM**. The mode of payment towards tender paper cost and EMD shall only be in the form of online or NEFT/RTGS on e-procurement portal of Government of Odisha. Any other form of payment will not be accepted by the tender inviting authority.
7. Bids security of the amount specified in the bidding document must be submitted through online or NEFT/RTGS. Bids must be submitted online on <https://tendersodisha.gov.in/> (website) on or before the date and time for receipt of bids, and the 'Technical Part' of bids will be opened online on the specified time and date for opening of bids, as given above. The "Financial Part" shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time. The electronic bidding system would not allow any late submission of bids.
8. The bidders are required to submit (a) ink signed & sealed copy of relevant documents, literatures, catalogue of product, test reports confirming to specifications for verification (b) original affidavit regarding correctness of information furnished with bid document (c) Manufactures authorization certificate to participate the bid, if the bidder is not an OEM (d) other document specified in the bid document to the General Manager (Mechanical), Odisha State Disaster Management Authority, Bhubaneswar before the opening of the technical part of the Bid given above, either by registered post/speed post/courier or by hand, failing which the bids will be declared non-responsive.
9. Other details can be seen in the bidding document. The Purchaser shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Purchaser shall not be liable for any information not received by
